ADDITIONAL GUIDELINES RELATED TO COVID PROTOCOLS

1. TRIBUNAL PENALTIES FOR COVID-RELATED INFRINGEMENTS

Clubs have a duty to ensure that players with COVID symptoms do not participate in training or games. Coaches have an influence over team behaviour and must ensure that players who are not well do not participate in training or games. If a coach is aware of a player being unwell, or showing symptoms, they must remove that player from training or game immediately. Coaches must be vigilant - negligent behaviour can impact their team, their club, other clubs or the whole competition.

- Coaches who play a player who is displaying COVID symptoms will be reported.
- Coaches who knowingly play a player with COVID, or play a player who has been advised to self-isolate for 14 days, risk a severe penalty.
- Coaches of a team whose behaviour is not reflective of the standard expected in the community will also be reported.
- Coaches shall be able to report other Coaches to the CEO for consideration of the use of the CIT process for COVID breaches.

The YJFL, at its sole discretion, may investigate any allegations or reported incidents or behaviour regarding players, officials or spectators with regard to COVID protocols.

Coaches must be supportive of umpire communications relating to COVID related concerns. Players may also be reported for misconduct in the event of clearing nasal passages during the match.

SET PENALTIES FOR COVID OFFENCES*:

Deliberate spitting at or on another person	8 weeks (Secondary age) 6 weeks (Primary age)

Knowingly play or allow a player to play with COVID or when advised by health authorities to be self-isolated	16 weeks

* Primary Age: under 12 and below; Secondary Age: U13 and above.

2. FIXTURING GAMES OF CLUBS IN 'HOT SPOT' SUBURBS

The League will make every effort to fixture games out of 'Hot Spot' suburbs. For matches outside the grading period, if a club is not happy to play a certain club in a match which may or may not have been re-featured, it can lodge a request to the league via their club President outlining their concerns about playing a club from a 'hot spot'. If reasonable, an alternate venue can be offered and if no compromise can be reached, the club who refuse to play their scheduled opponent may be considered to have forfeited the match. If however, the concerns are deemed to be justified by the YJFL in their sole discretion, then the match will be abandoned (see item 4 'Postponement & Cancellation of games').

If clubs refuse to play during grading period it is difficult to impose match penalties and even harder to grade those teams. This increases the chances of manipulation by coaches/teams who may conveniently opt out of grading games. Options available to the league include issuing club fines, or the loss of points for when matches commence, or grading teams in the higher grade.

3. HANDLING CONFIRMED COVID CASES

Clubs can be affected by the virus in multiple ways, including by players being diagnosed with COVID, players being instructed to isolate, or even due to the closure of schools.

If a player is diagnosed with COVID: If a player is diagnosed with COVID, the Club must follow all DHHS instructions and inform the League. DHHS will advise what changes the Club is to make to their operations. Once DHHS has completed all contact tracing and advised that the Club may re-open, any players who are not required to self-isolate may re-commence training or matches.

If a player is instructed to isolate: If a player is instructed to isolate, they must not attend any Club events, including training & matches.

If a School is closed: A player who attends a school which has been closed due to a confirmed COVID case is not to attend training or play in matches while their school remains closed. Once the DHHS has completed all contact tracing and advised that the school may re-open, any players who are not required to self-isolate may re-commence training or matches.

If a Club is contacted by DHHS: Where a club is contacted by DHHS due to a positive COVID test within the club, the club must follow all direction from the DHHS, which is likely to include the cancellation of training and matches, until they are advised that contact tracing has been completed and training and matches may re-commence.

Any individual subject to a direction by DHHS needs to declare that to the club and both the club and player must comply.

4. POSTPONEMENT & CANCELLATION OF GAMES

The AFL has issued a flow chart to guide Clubs as to the sequence of events that will occur when a COVID case is diagnosed within your extended community.

Within it, the YJFL approach to matches being unable to be played is described:

- (a) Games will not be played if not played as fixtured; no postponement is possible.
- (b) Cancellation of any match, prior to commencement, due to COVID 19 related issues, must be done in consultation with the League Football Operations Manager(s). This may include absences due to Stay Away requirements notified on the day of the match.
- (c) Presidents will be asked to confirm in writing a club's inability to field a team due to COVID 19 related issues.
- (d) Games will have no result entered and will not count towards the match ratio ladder result.
- (e) Matches that are terminated after commencement will be subject to the normal conditions as outlined in By-Law 3.7.
